3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sports and exercise attendant are:

Core task 1: Assisting in SE activities.

- 1.1 Recruits and informs SB participants
- 1.2 Prepares SE activities.
- 1.3 Supervises SE participants.
- 1.4 Carries out (parts of) SE activities
- 1.5 Supervises during SE activities.
- Core task 2: Carrying out duties for the SE organisation
- 2.1 Prepares organisation-related duties and performs them
- 2.2 Applies First (Sports) Aid and resuscitation
- 2.3 Performs maintenance duties
- 2.4 Performs simple front and back office work
- 2.5 Participates in internal discussions.
- 2.6 Evaluates activities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Sports and exercise leader works for fitness and health centres, sports clubs, government agencies, recreational companies, swimming pools, outdoor sports businesses, sports community work, education, sociocultural work and for sporting events.

The qualified Sports and exercise attendant may be employed in fitness and health centres, sports clubs and associations, government agencies, swimming pools and recreational companies. The Sports and exercise attendant may also be employed in sport-related retail sales.

Explanatory note

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. The format of the description is based on the following texts: Council Resolution 93/C 49/01 of 3 December 1992 on the transparency of qualifications, Council Resolution 96/C 224/04 of 15 July 1996 on the transparency of vocational training certificates, and Recommendation 2001/613/EC of the European Parliament and of the Council of 10 July 2001 on mobility within the Community for students, persons undergoing training, volunteers, teachers and trainers.

The education and training for this gualification is offered as of August 1, 2011.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
