The most important duties of a Pedagogical youth carer 4 are:

Core task 1: Draw up an activity programme and a plan of approach

- 1.1 Lists the situation and wishes of the child/young person
- 1.2 Draws up an activity programme
- 1.3 Draws up a plan of approach

Core task 2: Takes care of and supervises the child/young person

- 2.1 Supports the development and education of the child/young person
- 2.2 Offers the child/young person personal care
- 2.3 Takes care of the room and Household work
- 2.4 Offers the child/young person development-focused activities

Core task 3: Performs organization- and profession-related tasks

- 3.1 Participates in staff training and works on professionalization of the profession
- 3.2 Works on the improvement and assurance of quality care
- 3.3 Consults about the work with the stakeholders
- 3.4 Evaluates the work

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Pedagogical youth carer 4 can perform his/her work in semi-residential or residential institutions for youth care (for example surrogate family homes, guest houses, crisis centres, day-care treatment) and - subsequently – at the homes of the young people (activating support).

The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. <p><b>Access to next level of education/professions</b></p> <p>This programme gives access to higher vocational education (HBO), for example the programme Socio pedagogical assistance, Pedagogy, Cultural-social education, Teachers' training college or Social work and services. Via continuing education the Pedagogical youth carer 4 can move up to specialist functions, for example in the field of training.</p>	<p><b>International agreements</b></p> <p>The profession of Pedagogical youth carer 4 is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**Entry requirements**  
 The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
