The most important duties of an Entrepeneur/supervisor custom made clothes are:

The Entrepeneur/supervisor custom made clothes is conversant with both the content and commercial aspects of the business, including management, production processes and communication. He/she is able to independently undertake all professional activities in the made-to-measure clothing business: producing the full range of made-tomeasure ladies' and gentlemen's clothing, and managing a business in the made-to-measure clothing sector. He/she must for example be conversant with pattern drawing, cutting, stitching, but also be capable of running the business. He/she has knowledge of fabrics and haberdashery, fashion developments, purchasing and sales, stock control, business administration, financial management and personnel supervision.

- Entrepeneur/supervisor custom made clothes in the made-to-measure clothing business;
- Entrepreneur specialist;
- Wide range specialist;

International agreements The profession of Entrepeneur/supervisor custom made clothes is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
