3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Shoe repairman/entrepreneur are:

Core task 1: Repairs footwear and leather goods

- 1.1 Voorbereidende werkzaamheden verrichten
- 1.2 Repairs leather goods
- 1.3 Repairs soles
- 1.4 Repairs uppers and insides
- 1.5 Finishes off footwear and leather goods
- 1.6 Patches up the shoe either by machine or manually
- 1.7 Performs gaiter adjustments on boots
- 1.8 Maintenance of workplace and apparatus

Core task 2: Sells and gives advice

- 2.1 Assesses the requirement
- 2.2 Assesses and gives advice about the repair
- 2.3 Advises about (by-)products
- 2.4 Registers and completes sale/ repair
- 2.5 Deals with complaints
- 2.6 Presents articles

Core task 3: Running a business as a professional craftsman

- 3.1 Makes market analyses
- 3.2 Draws up a marketing plan
- 3.3 Draws up an investment budget and/or finance plan
- 3.4 Draws up an operating and liquidity budget
- 3.5 Attracts potential investors
- 3.6 Organises the business
- 3.7 Promotes and profiles the business
- 3.8 Purchases for the business and manages and monitors stocks
- 3.9 Carries out financial administration
- 3.10 Draws up and issues offers and price quotations
- 3.11 Reflects on the business

Shoe repairman/entrepreneur work in shoe repairer companies. These are mostly small companies comprising of one to a few employees.

Access to next level of education/professions With the certificate of Shoe repairman/entrepreneur, transfer is possible to a middle management or specialist course (qualification level 4). Shoe repairmen/entrepreneurs can work as self-employed entrepreneurs. By obtaining additional certificates and diplomas, Shoe repairmen / entrepreneurs can specialize in repairing orthopaedic shoes and fitting orthopaedic footwear provisions.	International agreements The profession of Shoe repairman/entrepreneur is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95590 The education and training for this qualification is offered as of August 1, 2011.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
