3. Profile of skills and competences

The most important duties of a Engineer all fishing vessels are:

Core task 1: Manages the technical running of fishing boats

- 1.1 Keeps the machine room watch
- 1.2 Operates main and assistant work vessels
- 1.3 Operates electrical and electronic apparatus
- 1.4 Coordinates and carries out maintenance working duties in the machine room
- 1.5 Carries out maintenance on cooling and freezing installations and sets them working
- 1.6 Manages the stock in the machine room

Core task 2: Is responsible (or shares responsibility) for the business management on fishing boats

- 2.1 Manages a small group of crew members
- 2.2 Guarantees a safe and environmentally responsible method of working
- 2.3 Carries out the administration concerned in the operational management

Core task 3: Works on a boat

- 3.1 Lives and works together with other crew members on a boat
- 3.2 Acts in cases of accidents, illness and calamities on board

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Engineer all fishing vessels works in the cutter or trawler fishery. Cutters mainly fish for round fish, flat fish, shrimp, cockles, and mussels. The cutter fishery can be divided up into two sections: coastal fishing and offshore fishing.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
