- 2.2 Determines and monitors implementation of work assignment
- 2.3 Prepares work tasks
- 2.4 Checks and adjusts colour (matching)
- 2.5 Processes finishing materials (topcoat)
- 2.6 Handover
- 2.7 Maintains workplace, tools and equipment

The Car spray painter level 3 carries out his work at the spraying department of the company.

5. OFFICIAL BASIS OF THE CERTIFICATE

Qualification level 3 of the Dutch VET qualification structure

Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. Access to next level of education/professions

The Car spray painter level 3 can move horizontally within the car bodywork sector to the qualifications Car repair technician level 3, Car damage mechanic level 3, Caravan mechanic level 3 or Body work builder level 3. Moving up is possible to qualifications at level 4 - the middle management positions - such as Workplace manager or Business manager. If the Car spray painter level 3 has the required competencies, promotion to managerial positions, such as department manager, workplace manager, or even business manager is possible.

International agreements

The profession of Car spray painter level 3 is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91780 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
