## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Work supervisor social care company - animals are:

Core task 1: Organises the care at the business

- 1.1 Balances working duties with need for care
- 1.2 Supervises working duties of those in need of care
- 1.3 Supervises those in need of care
- 1.4 Maintains contacts without outside organisations

Core task 2: Is responsible for the animal production

- 2.1 Organises the daily care of animals
- 2.2 Organises animal reproduction
- 2.3 Is responsible for the living and working environment
- 2.4 Carries out working duties at the animal farm

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Work supervisor social care company - animals works in the sector feed and living environment on an agricultural care business, where those in need of care can perform agricultural works within the framework of supporting supervision, social relief, social activation or getting people back to work.

<b>Access to next level of education/professions</b> With the certificate of Work supervisor social care company - animals, transfer is possible to a middle management or specialist course (qualification level 4).  The Work supervisor social care company - animals can, among other things, specialize in a certain group of people who are in need of care or a certain company specialization or he can expand the company with a sideline (agriculture and recreation, a farm shop, etc.). Promotion is also possible to managerial positions within larger animal farms or plant growing companies (that can be an agricultural care company or not).	<b>International agreements</b> The profession of Work supervisor social care company - animals is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97551 The education and training for this qualification is offered as of August 1, 2009.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
