The most important duties of a Data/electricity technician are:

- 1.2 Localises and analyses malfunctions

Core task 2: Carries out working duties in and starts up stations and/or data networks

- 2.1 Prepares working duties in stations and/or data networks
- 2.2 Assembles installations, components and appendages
- 2.3 Regulates, tests and inspects stations and/or data networks
- 2.4 Maintains and rectifies malfunctions in stations and/or data networks
- 2.5 Administers and finishes off working duties in stations and/or data networks
- 2.6 Supervises less experienced colleagues

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Data/electricity technician works in the sector technology (Kenteq)/construction & infrastructure (Fundeon). He works for a contractor, a power company, a water company, or a data communication company.

Higher vocational education technical/physics programmes such as Technical business administration, Electrical engineering, Data communication, Energy technology, Civil engineering, and Mechanical engineering are most logical.	International agreements The profession of Data/electricity technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.								
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92133 The education and training for this qualification is offered as of August 1, 2009.									

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
