3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Social legal assistant social security are:

Requests for social benefits or payments are directed to the desk of the Social legal assistant social security. This employee investigates whether the client is eligible, according to the statutory rules. On this basis, the assistant evaluates the request.

Main tasks of the Social legal assistant social security are:

- Accepting and dealing with applications for:
- social benefits (including income support payments);
- social security (General Old Age Pensions Act, Surviving Dependents Act, Exceptional Medical Expenses Act);

• employee insurance (depending on the institution where the work is carried out, Unemployment Insurance Act, incapacity for work insurance, Medical Expenses Act, Medical Expenses Insurance Fund Act). Specific tasks:

- holding interviews with clients;
- processing written requests;
- issuing information and providing explanations of various acts;
- preparing files to support the work and processing data in automated files;
- checking information provided by applicants or benefit recipients;
- investigating whether applications should be honoured;
- reporting and advising on requests and issuing proposals for settlements;
- correspondence;
- carrying out investigations.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Social legal assistant social security above all work for municipal social services, implementing bodies, medical expenses insurance funds and the Social Insurance Bank.

International agreements The profession of Social legal worker social security is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
