## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sports and exercise coordinator are:

The Sports and exercise coordinator offers sport and exercise activities independently, and in a professional manner. The Sports and exercise coordinator can be broadly deployed and is able to work with a range of target groups.

The professional character of the provision of sport and exercise activities and supervision of the sports and exercise participants is expressed in the planned, targeted and method-based organisation of those activities.

During the course of studies, the Sports and exercise coordinator specialises in one of the following professional variants:

- Sports and exercise consultant: offers sport and exercise activities aimed at encouraging movement skills and/or offering sport and exercise activities for social activation;
- Trainer/coach: offers sports and exercise activities to specific (groups) of sports and exercise participants, aimed primarily on the development of sporting techniques and sporting tactics. These specific groups may be: sportsmen and women at a particular level of competition, talented youth, the elderly, people with a functional limitation, with a chronic disorder or with particular physical difficulties;
- Exercise therapist: offers exercise activities aimed at encouraging movement skills in people with a limitation in mobility, psychiatric and/or social disorders. An exercise therapist can be found in, for instance, help care for youth, addicted people, in penitentiary institutions and/or centers of revalidation;
- Operational sports and exercise manager: undertakes coordinating and management tasks within a sports and exercise organisation.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Possible positions to be occupied by a Sports and exercise coordinator: support teacher, youth sport consultant, policy worker, trainer/coach, sport promotion worker, movement therapist, company manager.

<b>Access to next level of education/professions</b> With a diploma at qualification level 4, transfer is possible to higher professional education.	<b>International agreements</b> The profession of Sports and exercise coordinator is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
<b>Average duration of the education/ training leading to the certificate</b>	<b>4 year(s) (6400 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
