## 3. PROFILE OF SKILLS AND COMPETENCES

The most important tasks of an All-round worker fresh produce industry are:

Core task 1: Prepares the process of the production and processing of fresh products.

- 1.1 Makes machines ready for use and/or sets out (packaging) materials and tools
- 1.2 Receives raw materials and consumables for the production/processing of fresh products and identifies malfunctions
- 1.3 Signals deficiencies in good time and passes them on

Core task 2: Carries out production and processing of fresh products

- 2.1 Treats and/or processes fresh products manually and/or with the aid of machines
- 2.2 Checks fresh products during production/processing and/or monitors the production/processing of fresh products
- 2.3 Removes waste and/or residual products
- 2.4 Cleans and/or disinfects
- 2.5 Rounds off working duties

Core task 3: Organises the process of the production and processing of fresh products.

- 3.1 Monitors the progress of the production/processing of fresh products
- 3.2 Coaches and supervises employees professionally
- 3.3 Makes proposals to optimise production/processing of fresh products

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round worker fresh produce industry carries out production duties in several fresh segments of the fresh industry. He could be employed by companies which deal with the production and/or the processing of meat, cold meats, game, poultry, convenience, fruit and vegetables and/or fish. He could also be employed in a slaughterhouse and slaughter cows, calves or pigs in the clean or dirty slaughterhouse.

<p><b>Access to next level of education/professions</b> The All-round worker fresh industry can transfer to Production manager fresh industry (level 4).</p>	<p><b>International agreements</b> The profession of All-round worker fresh industry is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25427 The education and training for this qualification is offered as of August 1, 2015.</p>																					

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
