3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a System manager SME are:

The System manager SME is responsible for management, protection and maintenance of automised information systems in SME's. He/she combines the work of the system manager and the application manager, manages all central data of the company, which are used by several people, takes care of the software and hardware, develops internal procedures for use and management of information systems, and trains users/colleagues. Students are prepared for the profession of System manager SME by training in management, protection and maintenance of information systems. This middle management training focuses both on software and hardware procedures. Apart from very practically oriented subjects, the modular education system also contains subjects such as economic administrative training and civil and cultural education.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The System manager SME can be employed in small and medium sized enterprises as: system manager, network manager or ICT manager.

The system, network or ICT manager is generally the only person in the organisation working in this field.

5. OFFICIAL BASIS OF THE CERTIFICATE

The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education. Culture and Science pupil attended the programme.

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions

With a diploma at qualification level 4, transfer is possible to higher professional education.

International agreements

The profession of System manager SME is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 10031

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
