Core task 3: Takes care of maintaining business relationship and client support

- 3.1 Maintains customer contact and performs after sales activities
- 3.2 Handles complaints
- 3.3 Carries out promotional activities
- 3.4 Carries out webcare activities

Core task 4: Organises and carries out the import and export activities

- 4.1 Supports the tendering process for (import) suppliers
- 4.2 Drafts import and export documents and manages them
- 4.3 Supervises import and export orders and coordinates the shipping/transport
- 4.4 Contributes to optimising import and export processes

Core task 5: Drafts an export/marketing plan

- 5.1 Maps out export markets

Through higher professional education, a logical step towards further education would be International business and languages.</p>	<p>International agreements The profession of Assistant manager international trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
