The most important duties of a Skilled commercial vehicle mechanic are:

Core task 1: Carries out maintenance on commercial vehicles

- 1.1 Prepares maintenance assignment on commercial vehicle
- 1.2 Carries out inspection of commercial vehicle
- 1.3 Carries out preventive maintenance on commercial vehicle
- 1.4 Installs accessories in commercial vehicle
- 1.5 Carries out technical adjustments on commercial vehicle
- 1.6 Checks their maintenance working duties and finishes off assignment
- 1.7 Supports and instructs trainees and colleagues during maintenance working duties
- 1.8 Gives technical explanations and advice about maintenance to client/ driver

Core task 2: Carries out repairs to commercial vehicles

- 2.1 Prepares repair assignment in workplace or on location
- 2.2 Carries out repair to commercial vehicle in workplace
- 2.3 Makes diagnosis of commercial vehicle on location
- 2.4 Carries out (emergency) repairs to commercial vehicle on location
- 2.5 Checks their maintenance working duties and finishes off assignment
- 2.6 Supports and instructs trainees and colleagues during maintenance working duties
- 2.7 Gives technical explanations and advice about maintenance to client/ driver
- 2.8 Is responsible for sharing knowledge about repair situations within the business

Core task 3: Makes diagnosis of commercial vehicles

- 3.1 Prepares diagnosis assignment
- 3.2 Makes diagnosis of commercial vehicle in workplace
- 3.3 Checks their diagnosis working duties and finishes off assignment
- 3.4 Is responsible for sharing knowledge about diagnosis situations within the business

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Access to next level of education/professions

There is a continuous learning line from levels 2 up to and including 4 within the intermediate vocational education. Within the sector, comparable promotion is possible from first commercial vehicle mechanic level 3 to technical specialist commercial vehicles level 4.

International agreements

The profession of Skilled commercial vehicle mechanic is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93450 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
