4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Groomer is service provider, in that he carries out specialized works for his clients, on pet animal hair, nails, fur, and inspects ears and teeth. He also gives cosmetic treatment. Usually, the Groomer works as a self-employed entrepreneur without any staff. Sometimes, the Groomer works for a company that keeps animals.

<p>Access to next level of education/professions As knowledge and skills grow due to experience, Groomers will specialize in various breeds. Groomers can expand their company by hiring staff, which will give more emphasis on the entrepreneurship-side of their enterprise. There are no more career opportunities within this vocation.</p>	<p>International agreements The profession of Groomer is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97460 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
