3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled mechanic electrical industrial installations are:

- to install cable installations for industrial installations;
- cooperate and supervise these installations;
- to modify industrial switching and distribution devices;
- maintenance of the installations:
- to operate and search for failures in the installations.

The Skilled mechanic electrical industrial installations is responsible for the execution of his set of tasks consisting of applying and combining of standard procedures and devising of procedures. The employee checks and supervises the application of automated routines and standard procedures by others and in this context carries hierarchical responsibility.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled mechanic electrical industrial installations is in general employed in the industry or with electro technical installation engineering contractors and carries out work on and for the purpose of low-voltage industrial installations.

International agreements The profession of Skilled mechanic electrical industrial installations is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
