- 2.2 Works on the improvement and assurance of quality care

Core task 3: Raising and developing the child/children

- 3.1 Carries out interviews with the parents/guardians and child
- 3.2 Draws up a (specialised) activity programme
- 3.3 Helps in developing a support plan
- 3.4 Offers (specialised) care
- 3.5 Offers personal care
- 3.6 Takes care of household work
- 3.7 Offers development-focused activities

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Specialised pedagogical carer works in a children's centre which offers services such as childcare, school care, playgroup work, pre- and early school education as well in organisations offering these services, such as an integral child centre or community school. The Specialised pedagogical carer can also work in organisations offering parenting support and/or support to children or adolescents with specific support questions, such as on the subject of developmental delay, whether this is caused by a sensory, physical or mental disorder, whether caused by the living or parental situation. The Specialised pedagogical carer generally works with a group of children, i.e. at least two children.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
