<p><b>Access to next level of education/professions</b> Completion of this programme gives access to higher vocational education.</p> <p>In the professional musical world, one usually works for one of the main producers; the musical artist generally is first given a place in the ensemble. In the big productions a musical artist can usually work his way up via an understudy role to the leading role. This, however, is only granted to a relatively small number of people. Except within a musical production, musical artists find work in the socio-cultural Work, in tourism and/or the hotel and catering industry, in the media world of in the field of training and/or coaching, but also in education/arts education.</p>	<p><b>International agreements</b> The profession of Artist - musical is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90033 The education and training for this qualification is offered as of August 1, 2008.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
