3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor gardening company are:

The activities of the Supervisor gardening company are managing, preparing and planning the daily activities in landscaping and gardening. Depending on the scope of the company and technical knowledge executive tasks can be performed as well.

He plans work activities, directs tasks, supervises the activities, inspects, registers worked hours and used material. He is also involved in tasks in the field of tenders and calculations, design specifications and acquisition. He communicates with clients and has supervision. He is able to anticipate and takes decisions at all kinds of different company situations. He is responsible for his own work and that of its employees. He is the internal chief with a binding function between acquisition, design work, finances and realisation.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession of Supervisor gardening company is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
