#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Agricultural technician are:

The Agricultural technician is a specialist in the field of technical systems employed in the agricultural sector. He is involved in the production, maintenance and repair of equipment and machines in the field of agricultural mechanisation technology, control technology/hydraulics and refrigeration and freezing technology.

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

To be broken in various groups:

- Technical manager agricultural mechanisation is responsible for independently issuing diagnoses on complex installations and equipment, preparing repair plans and implementing repairs (or having them implemented) and final inspection.
- Workshop head is in charge of the day-to-day operation of the workshop in an agricultural mechanisation business. He is responsible for achieving operational targets in the workshop, both technical and economic.
- Company manager is in charge of and responsible for the policy, management and operational aspects of a small or medium-sized enterprise in the agricultural mechanisation sector.
- Salesman a salesman is responsible for the marketing, sales and after sales service in a small or mediumsized enterprise in the agricultural mechanisation sector. He is responsible for drawing up target group lists and sales plans and preparing and issuing quotations.

However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
