The Security coordinator works for company security services or is in employment of privately held security businesses that sends him to clients. He works for all kinds of companies and organizations, from oil refineries to ministries. The specialization is specifically meant for team leaders and object coordinators in privately held security

Access to next level of education/professions With the certificate of professional training, transfer is possible to a middle management or specialist course (qualification level 4). Within the security sector, the Security coordinator can rise to the position of unit assistant, unit manager, area manager, entrepreneur, security consultant, and safety consultant. A higher position outside the security sector is facility services manager. The intermediate vocational education qualification of Facility services manager is suitable for this.	International agreements The profession of Security coordinator is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
