3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Junior product manager fashion are:

Core task 1: Provides input to collection development in order to improve sales

- 1.1 Gathers commercial information
- 1.2 Analyses data for the development of the fashion collection
- 1.3 Makes proposals for the collection plan
- 1.4 Monitors product specifications
- 1.5 Makes price calculations for the commercial viability of the collection
- 1.6 Presents commercial data

Core task 2: Prepares production of collection items

- 2.1 Processes order data
- 2.2 Prepares purchase orders
- 2.3 Advises on the definitive production

Core task 3: Plans and watches over the collection production

- 3.1 Does the production planning
- 3.2 Monitors production planning, the production process and the logistics
- 3.3 Assesses samples
- 3.4 Maintains contact with stakeholders

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Junior production manager works within the fashion branch of industry. This can be within a business process outsourcing, wholesale, or retail organisation. This can involve a company developing & selling products of its own 'label' and/or having products custom-made to be sold as a 'private label'. Furthermore the resources and parts can also be bought by the company itself. In such a concept, only production is outsourced.

<p>Access to next level of education/professions After achieving this qualification, a Junior production manager fashion can develop through a higher professional education related to management in branches such as fashion or textile.</p>	<p>International agreements The profession of Junior product manager fashion is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25157 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 / 6400 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
