- 1.3 Makes proposals for a policy or tools plan
- 1.4 Elaborates (part of) a policy or tools plan
- 1.5 Comments on (part of) a policy or tools plan

Core task 2: Sets up marketing and or communications activities and realizes them

- 2.1 Describes a marketing and/or communications issue
- 2.2 Thinks up a solution
- 2.3 Draws up a project plan
- 2.4 Implements a project plan
- 2.5 Evaluates the project plan and the achieved result
- 2.6 Develops and manages information, promotion and or pr materials

Core task 3: Organizes events

- 3.1 Consults with client
- 3.2 Makes a scenario and amplifies it
- 3.3 Arranges transport of materials and persons
- 3.4 Arranges rooms and installs materials
- 3.5 Takes care of daily provisions
- 3.6 Performs support activities in the field of personnel matters
- 3.7 Organizes the security of locations
- 3.8 Assists during the event

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Event organization officer mainly works for organizations that are involved in the organization of events, such as concerts, festivals, tours and competitions.

<b>Name and status of the body awarding the certificate</b> The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.	<b>Name and status of the national/regional authority providing accreditation/recognition of the certificate</b> Ministry of Education, Culture and Science
<b>Level of the certificate (national or international)</b> Qualification level 4 of the Dutch VET qualification structure Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures. <b>Access to next level of education/professions</b> Completion of this programme gives access to higher vocational education (hbo).  The Event organization officer can grow into functions at the hbo level, involving team management and work in accordance with policy.  Many graduates of the Event organization officer programme continue their studies. Hbo programmes that are related to this qualification file with regard to content are Commercial economics and Communications.	<b>International agreements</b> The profession of Event organization officer is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90534 The education and training for this qualification is offered as of August 1, 2008.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
<b>Average duration of the education/ training leading to the certificate</b>	<b>4 year(s) (6400 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
