### 3. Profile of skills and competences

The most important duties of a Manager port operations are:

Core task 1: Coordinates and monitors the operational process for the sake of the harbour

- 1.1 Prepares the operational process
- 1.2 Makes and monitors the planning
- 1.3 Monitors the progress and manages the execution of the operational process
- 1.4 Manages colleagues in the implementation of the operational process
- 1.5 Registers and reports information regarding the operational process
- 1.6 Makes sure that the machines, tools and materials are used adequately
- 1.7 Signals and acts when there are problems and during unsafe situations in the operational process
- 1.8 Carries out operational working duties for the sake of the loading process and the unloading process

Core task 2: Monitors an efficient business exeuction

- 2.1 Monitors the execution of the department plan
- 2.2 Monitors the execution of the care systems
- 2.3 Provides management information
- 2.4 Contributes to the optimalisation of the operational processes
- 2.5 Organises meeting discussions
- 2.6 Carries out performance and assessment interviews

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager port operations is employed in a bulk transhipment, container transhipment, roro company or mixed cargo company for the benefit of the harbour. This organisation is 24/7 occupied with loading and unloading of modes of transport such as sea ships, inland vessels, train compartments and lorries.

# Access to next level of education/professions

After this qualification, the Manager port operations can do various higher professional education programmes, for instance for Technical transport.

#### International agreements

The profession of Manager port operations is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

# Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95726 The education and training for this qualification is offered as of August 1, 2012.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

#### Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

#### 7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
