The most important duties of a Social pedagogical carer 3 - care for the disabled are:

The Social pedagogical carer 3 - care for the disabled deals with the provision of help and service within the framework of the primary home and living situation, be it in the own home or in alternative accommodation. The help and service provided by the Social pedagogical carer 3 - care for the disabled includes care and attendance aspects, often in combination. The professional nature of this help and service may be recognized in the systematic. goal-oriented and methodical set-up thereof. The Social pedagogical carer 3 - care for the disabled works within a team or is from the basis of an organisation.

5. OFFICIAL BASIS OF THE CERTIFICATE on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives

access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 3 year(s) (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
