3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Veterinary nurse are:

The Veterinary nurse carries out the daily reception tasks (reception of animals and owners, answering telephone calls, making appointments). She orders medication and materials according to instruction. She informs owners about daily animal care, medication etc.

A Veterinary nurse carries out her tasks under command or under guidance of the veterinarian. The Veterinary nurse has enough experience to act as a skilled operation assistant to the veterinarian. In case of an emergency the Veterinary nurse acts independently when the veterinarian is absent.

According to the 'Besluit Paraveterinairen' the Veterinary nurse has to do with the 'Wet uitoefening Dierengeneeskunde'. For the execution of paraveterinary actions the Veterinary nurse has to work according to the disciplinary rules of this law.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
