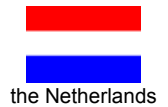

3. PROFILE OF SKILLS AND COMPETENCES
<p>The most important duties of an Assistant process technology worker are:</p> <p>Core task 1: Works as an assistant in a labour organisation</p> <p>1.1 Prepares (assistant) work</p> <p>1.2 Carries out (assistant) tasks</p> <p>1.3 Reports on completing his (assistant) tasks</p> <p>Core task 2: Assists in the (sub) production process</p> <p>2.1 Starts and operates equipment</p> <p>2.2 Assists in process operation and quality controls</p> <p>2.3 Assists in simple maintenance tasks</p>

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE
<p>The Assistant process technology worker is employed in a company carrying out routine work for various sectors and may be employed either in a team or to work independently. He is flexibly employable and his primary task is to ensure the smooth operation of the production process.</p>

<p>Access to next level of education/professions The Assistant process technology worker can in principle enter all study courses at level 2. The Assistant process technology worker wishing to progress in the same field can advance to the level of basic professional practitioner as operator A or operator production technology. It is also possible to switch to another sector in the process industry.</p>	<p>International agreements</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>1 year (1600 study hours) (depending on previous education)</p>
<p>Entry requirements There are no legal educational requirements.</p>	

7. ADDITIONAL INFORMATION
<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at http://kwalificaties.s-bb.nl/, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.</p> <p>Additional information, including a description of the Dutch national qualifications system, is available at the Netherlands National Reference Point (NRP): www.s-bb.nl. The NRP is the information centre for vocational qualifications in the Netherlands. SBB has been appointed in this capacity by the Ministry of Education, Culture and Science.</p>
