3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Video engineering worker are:

- Assisting in set construction;
- Independently making simple recordings;
- Operating, developing and printing machines;
- Carrying out simple digital processes;
- Archiving photographs.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The position Video engineering worker relates primarily to auxiliary activities in photography and video technology. The tasks can range from putting in place the products to be photographed via producing simple photographs or preparing props on a set for a video production, right through to producing simple video reports.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
