3. PROFILE OF SKILLS AND COMPETENCES

The most important tasks of the Supervisor biological laboratory technology are:

- independently carrying out inspection work for the required quality assurance and/or 'good laboratory practices';
- independently undertaking administrative and management tasks;

- independently undertaking authinistrative and management
- independently reporting results verbally and in writing;

- undertaking biological routine analyses, according to instructions, on material of vegetable, animal or human origin.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor biological laboratory technology independently undertakes botanical, (micro)biological and/or biotechnological studies in (micro)biological and/or botanical laboratories or in hospital laboratories. These include the areas of attention such as analyses in (medical) microbiology and/or food microbiology and/or fermentation technology and/or culture methods in botanics and application of DNA techniques. The precise techniques will vary depending on differentiation, and will eventually determine the sector in which the Supervisor will work. He/she can independently isolate and determine organisms, and place them in culture.

Access to next level of education/professions With a diploma at qualification level 4, transfer is possible to higher professional education.	International agreements The profession of Supervisor biological laboratory technology is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
