4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled worker fresh produce trade, logistics and transport works for a wholesaler that trades and processes food and green products. This includes trading and processing flowers, plants, potatoes, vegetables, fruit, or other living products and/or foods.

| <p>Access to next level of education/professions Within the sector, the Skilled worker fresh produce trade, logistics and transport can be promoted to managerial positions such as assistant business manager, team leader, box or shed head. The qualification/training to Manager fresh produce trade, logistics and transport is a good choice for this.</p> | <p>International agreements The profession of Skilled worker fresh produce trade, logistics and transport is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p> |

| 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE | |

| <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |
