#### PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor environment and open spaces are:

Core task 1: Carries out investigations in the environment and open spaces

- 1.1 Carries out investigations and measurements
- 1.2 Interprets and reports the results of environmental investigations and/or redevelopment

Core task 2: Carries out legal and regulatory requirements concerning the environment and open spaces

- 2.1 Makes reports and requests licences
- 2.2 Deals with reports and requests for simple licences
- 2.3 Maintains supervision
- 2.4 Makes reports and/or gathers information about licences
- 2.5 Deals with infringements
- 2.6 Looks into and deals with complaints

Core task 3: Supervises and provides information about environmental aspects

- 3.1 Provides information about environmental regulations and legislation
- 3.2 Supports care systems
- 3.3 Interprets care systems

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor environment and open spaces works for municipalities and provinces in the department of environment and/or spatial planning, for water boards, polder boards, consultancies, contractors that carry out investigation and remediation, and production companies.

# Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

### Access to next level of education/professions

The Supervisor environment and open spaces can rise to a consulting, policymaking, or managerial position, such as project manager. He can also do a relevant higher vocational education programme, for instance, for Land and water management or for Environmentology.

## International agreements

The profession of Supervisor environment and open spaces is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97371 The education and training for this qualification is offered as of August 1, 2009.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# Average duration of the education/ training leading to the certificate

4 year(s) (6400 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
