3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Afro hairdresser are:

- 1.4 Cares for the hair and the scalp
- 1.5 Cutting hair

Core task 2: Styles hair

- 2.1 Carries out analysis of hair and scalp
- 2.2 Makes up or adjusts a treatment plan after consultation and prepares treatment
- 2.3 Cutting long hair
- 2.4 Blow-drying and styling
- 2.5 Temporary styling
- 2.6 Permanent styling
- 2.7 Selling and advising about products and services

Core task 3: Colours and bleaches hair

- 3.1 Carries out analysis of hair and scalp
- 3.2 Makes up or adjusts a treatment plan after consultation and prepares treatment
- 3.3 Colours and bleaches hair
- 3.4 Completes treatment and brings administration up-to-date

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Afro hairdressers work in various types of hairdresser's: specialised ladies' hairdressers, specialised barbers, mixed hairdressers, and specific hairdressers. There are also travelling hairdressers: hairdressers who go to the customer's home.

<p>Access to next level of education/professions Within the sector external care, horizontal promotion is possible to the qualifications of Pedicurist or Beautician based on a completely obtained diploma Afro hairdresser.</p>	<p>International agreements The profession of Afro hairdresser is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
