3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor construction engineering are:

- make the final design and plans which meet the requirements of the demands of the building permit and the tender;
- describe building and construction project information, with the help of Stabu-systematics;
- work out plans and work drawings for construction and prefab building elements;
- make drawings and models for presentations;
- estimate the calculation of costs of a work;
- analyse the working process;
- control the circumstances of labour on the building site;
- order and control the delivery of building materials;
- design and arrange the building site;
- peg out and measure a building;
- assist the general foreman with carrying out the work;
- make and co-ordinate maintenance plans;
- survey real estate for rent mutations;
- undertake activities with the help of computers;
- participate in meetings (including delivering of a report);
- work in teams;
- read specialist literature in the German and English language.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor construction engineering is primarily employed by firms of architects, construction firms, structural consultancy firms, implementing construction companies, government organisations or real estate management companies.

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Qualification level 4 of the Dutch VET qualification structure</p> <p>Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>4 year(s) (6400 study hours) (depending on previous education)</p>
<p>Entry requirements</p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
