3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Farrier are:

Core task 1: Trims hooves, nails horseshoes and provide advice

- 1.1 Investigates the wishes of the client and advises
- 1.2 Determines treatment
- 1.3 Sets up workplace, handles animal and cleans up after work
- 1.4 Trims horse or pony
- 1.5 Fits horseshoes
- 1.6 Nails on horseshoes on horse or pony

Core task 2: Leads an enterprise

- 2.1 Deals with complaints
- 2.2 Gives shape to the freelance company/sole proprietorship
- 2.3 Presents and promotes the business
- 2.4 Organises the financial progress
- 2.5 Does purchasing for the company (products and/or services)
- 2.6 Innovates

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Farrier almost always works at a client's company/terrain, where he works on the hooves of horses and ponies. The Farrier usually works freelance and in some cases with a few employees. Some Farriers are employed by a horse farm, equestrian enterprise, veterinarian practice or animal clinic.

<p>Access to next level of education/professions A Farrier can specialise in horses for certain equestrian disciplines or in nailing hooves therapeutically an correctively for horses and ponies with deviant leg positions, leg defects and hoof diseases. Aside from standard farrier work, a Farrier can also carry out a wide range of other activities, such as horse trade, decorative farrier work or insurance expert. Further education is desirable for these activities. The Farrier can also develop through a compact VET-level 4 education in entrepreneurship.</p>	<p>International agreements The profession of Farrier is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25467 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
