The most important duties of an Instrument maker are:

The Instrument maker independently, within a business/institution manufactures and modifies instruments and precision mechanical devices, and assembles, disassembles, maintains and tests existing devices.

These products are manufactured from steel (alloys), non-ferrous metals, plastics, technical ceramics and glass.

The parts are manufactured by means of machining on small to medium-sized centre lathes, universal milling machines, universal grinding machines and coordinate drilling machines with accessories.

Use is also made of the following joining techniques: screwing, pinning, gluing, soldering, welding, pressing, crimping and forcing.

The Instrument maker is employed in: workshops of businesses and research institutes.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 2 year(s) (3200 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
