3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round welder are:

Core task 1: Creates products

- 1.1 Does preparatory work for one's own work
- 1.2 Sets and adjusts machine and tools
- 1.3 Manufactures and transforms material
- 1.4 Measures and checks manufactured products
- 1.5 Rounds off completed work

Core task 2: Carries out welding tasks in any position

- 2.1 Does preparatory work for specific welding jobs
- 2.2 Sets up and adjusts welding machine and welding tools
- 2.3 Does preparatory work for seam welding
- 2.4 Does welding tasks
- 2.5 Supervises less experienced colleagues
- 2.6 Completes specific welding activities

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round welder works in the technology sector and generally works for companies within the metal products industry. The All-round welder can also work in the machine industry, electro-technical industry, transport equipment and construction. He can also carry out welding tasks in any occurring position.

International agreements The profession of All-round welder is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25287 The education and training for this qualification is offered as of August 1, 2015.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
Average duration of the education/ training leading to the certificate	3 years (4800 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
