- 1.4 Negotiates about prices and conditions and forms agreements

Core task 2: Manages media projects and/or production

- 2.1 Formulates a plan of approach (project plan)
- 2.2 Plans the media production
- 2.3 Organises the collaboration with third parties and matters of liability concerning the production
- 2.4 Manages the finances within the project
- 2.5 Manages the available time, means and flow of information
- 2.6 Maintains the quality of media products
- 2.7 Is responsible for maintaining conditions for safety, working conditions and the environment

Core task 3: Manages the content

- 3.1 Is responsible for (medium neutral) storage of content
- 3.2 Determines which content is suitable
- 3.3 Is responsible for (medium neutral) storage of content

The Media content manager often works for companies such as communication companies, advertising agencies, specialized design studios, web design companies, multimedia companies, audiovisual companies, publishers and printers.

| <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |
