3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Journeyman floor layer are:

Core task 1: Lays floors

- 1.1 Prepares the work
- 1.2 Prepares the underfloor
- 1.3 Lays floor coverings
- 1.4 Carries out clearing up duties
- 1.5 Delivers floor coverings

Core task 2: Repairs floors

- 2.1 Prepares to do repair work
- 2.2 Carries out repair work

Core task 3: Carries out practical project management

- 3.1 Prepares the project
- 3.2 Manages colleagues
- 3.3 Coaches students/new employees
- 3.4 Monitors quality and progress of project
- 3.5 Delivers the project

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Journeyman floor layer is usually employed in companies in the branch of outfitting, specifically within the flooring sector. He can also work as an independent contractor. He works for various kinds of clients within the residential and utility construction (both constructing and maintenance in either case). Depending on the kind of company he works for, he places cement floors, self-levelling floors, synthetic floors, monolithic floors or terrazzo (floors and/or elements). The Journeyman floor layer also occasionally does non-constructive repair work on floors.

<p>Access to next level of education/professions A Journeyman floor layer can develop to a position in middle management (such as building site supervisor or entrepreneur). This can be done through the Outfitting, maintenance and interior executive education or through technical courses.</p>	<p>International agreements The profession of Journeyman floor layer is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25004 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
