Core task 2: Offers supportive, activating supervision and care

- 2.1 Supports the client in their personal care
- 2.2 Supports the client in accommodation and household duties
- 2.3 Supports the client in their daily business
- 2.4 Supports the client in running their own life
- 2.5 Supports the social system
- 2.6 Carries out technical nursing treatments

Core task 3: Carries out organisational and professional tasks

- 3.1 Works at the improvement in professionalism and the professionalization of the profession
- 3.2 Works at the improvement and monitoring of the quality care
- 3.3 Balances the working duties together with those involved
- 3.4 Carries out coordinating tasks
- 3.5 Evaluates the support offered

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Carer for the disabled is part of the sector social community work and the sector care and welfare. Typical of the social care is the methodical and goal-oriented supervision of a client or a group of clients and possibly the client system with the purpose of improving the client's wellbeing and/or the client system and an existing (problematic) situation.

<p>Access to next level of education/professions The diploma of Carer for the disabled allows enrolment in the programme for Carer for adults and in other senior secondary vocational trainings at level 4, such as Pedagogical care, Socio-cultural worker, Teaching assistant or Social worker or Nurse.</p>	<p>International agreements The profession of Carer for the disabled is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92661 The education and training for this qualification is offered as of August 1, 2008.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
