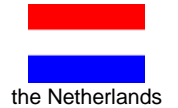

The Assistant operator production technology is mainly employed by medium-size and large companies, in the production department in various industrial sectors such as: - companies in the metal production industry; - foundries, electro technical industry; - machine industry; - transport vehicle industry; - wood and furniture industry; - and other companies in the process industry. He/she works in a mechanical environment where both metal products and other products are produced. He/she is versatile and can work with various types of equipment in the production.

Moreover it is possible to transfer to another sector within the process industry. ### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>1 year (1600 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  There are no legal educational requirements.</p>
