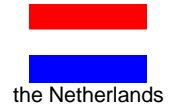

3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Junior military personnel are:

Core task 1: Undertaking military skills

- 1.1 Prepares military assignments
- 1.2 Prepares equipment for use and maintains personal equipment
- 1.3 Prepares for deployment
- 1.4 Survives in an operational environment
- 1.5 Takes countermeasures against CBRN and TIM
- 1.6 Takes countermeasures against ammunition and mines
- 1.7 Acts in cases of incidents and calamities
- 1.8 Evaluates his performance

Core task 2: Supervising and carrying out coordinating tasks

- 2.1 Communicates the plan to the team
- 2.2 Issues the team instructions

Core task 3: Carrying out military security tasks

- 3.1 Establishes checkpoints, roadblocks, base guards and guard posts
- 3.2 Carries out social patrols
- 3.3 Carries out reconnaissance patrols
- 3.4 Carries out surveillance and inspections
- 3.5 Carries out entrance and exit inspections

Core task 4: Carrying out basic technical and basic logistical skills

- 4.1 Carries out basic maintenance on vehicles and prepares them for deployment
- 4.2 Checks and maintains communication equipment
- 4.3 Is responsible for keeping items of equipment and vehicles in operation

<p>Access to next level of education/professions The Junior military personnel ground troops enters employment with the Royal Netherlands Army following completion of training. Following training, a small proportion of students will transfer to the Royal Netherlands Marechaussee or the Royal Netherlands Airforce. There are specific examples of vertical transfer for Junior military personnel to Junior non-commissioned officer at level 3 or Private security (level 3 Security coordinator) or supervision and security services (level 3 Supervision and security officer). However, any student wishing to become a security coordinator must first have acquired the certificate for Security officer level 2.</p>	<p>International agreements</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
