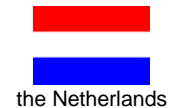

<b>4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE</b>
<p>The Security officer who works as a Shop security officer works in a shop or shopping mall. He works in various shifts, on secondment or employed by the company that has to be secured.</p>

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Characteristics: intended as an initial qualification, which everyone should at least obtain. The participant develops skills in order to be able to carry out practical tasks and is responsible for his or her own block of tasks.</p> <p>NLQF level 2 - EQF level 2 - ISCED 3C</p>	<p>7 very satisfactory 6 pass 5 fail 4 unsatisfactory 3 very unsatisfactory 2 poor 1 very poor</p>
<p><b>Access to next level of education/professions</b> Shop security officers can grow into the function of manager/coordinator or become part of a mobile intervention team. For job-specific specialisation within shop security there is no qualification of secondary vocational education (mbo).</p>	<p><b>International agreements</b> The profession of Shop security officer is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.</p>
<p><b>Legal basis</b> Adult and Vocational Education Act (WEB), registered number of qualification (crebo): 90545 The education and training for this qualification is offered as of August 1, 2008.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION
<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file, that is composed by the Centre of Expertise.
