- 1.8 Manages the workplace stock

Core task 2: Repairs jewellery and implements

- 2.1 Analyses repair assignment
- 2.2 Outsources working duties
- 2.3 Disassembles, repairs and replaces parts
- 2.4 Finishes off and inspects jewellery and implements
- 2.5 Makes and adjusts professionally specific tools

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A **Basic goldsmith** is a craftsman who makes and repairs jewellery, objects and/or items of (precious) metals, sometimes embellished with gems and other materials. He is an independent craftsman and, generally, a self-employed entrepreneur. He sells his own work and sometimes work by others, or through a jeweller or gallery. Sometimes he will exhibit his work.

<p>Access to next level of education/professions A Basic goldsmith can train to become a goldsmith and will then have the same career opportunities as the gold/silversmith.</p>	<p>International agreements The profession of Basic goldsmith is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
