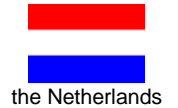

<b>4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE</b>
<p>The Sports and exercise attendant can work in fitness and health centres, sports associations and clubs, public organizations, swimming pools and recreational companies. The Sports and exercise attendant can also work in sports-related retail trade. Sports and exercise require specifically equipped accommodations.</p>

<p><b>Access to next level of education/professions</b>            The certificate Sports and exercise attendant gives access to level 3. Within Sports and exercise, at level 3 the programme leading to Sport and exercise leader is offered.            The sports federations and other sports organizations also offer a large diversity of training programmes. In some cases the participants can earn the applicable certificates or diplomas in the programme of sport and exercise guide. In other cases, they can be granted exemption or the certificate sports and exercise is sufficient. In these (branch) organizations there are also possibilities for the applicable transfer to a higher level.</p>	<p><b>International agreements</b></p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).            In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.            In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>            The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
