3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Specialist floristry flower arranger are:

The Specialist floristry flower arranger performs all attentive flower work independently and works innovatively. The work concerns composing and binding special bouquets using different techniques; making flower arrangements for special occasions and designing and realisation of special flower arrangements. He is able to organise work activities and leads his team concerning profession technique and is responsible for the employees placed under his control. He takes care of the lay-out and fitting of the shop and the product presentation. He handles purchases, sales, stock management, order administration, conduct and settle complaints. He shows commercial insight.

The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education, Culture and Science pupil attended the programme.

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. 5. OFFICIAL BASIS OF THE CERTIFICATE

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 year(s) (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
