3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Assistant manager logistics wood trade (level 4) are:

Core task 1: Receives and stores products

- 1.1 Receive and checks goods/products
- 1.2 Loads products, prepares them for storage
- 1.3 Divides and keeps products
- 1.4 Makes an inventory of the stock

Core task 2: Gathers and makes products ready for shipment

- 2.1 Gathers and moves products
- 2.2 Carries out VAS activities
- 2.3 Makes goods and/or products ready to ship
- 2.4 Delivers products to an external mode of transport

Core task 3: Manages

- 3.1 Plans and divides logistic working duties
- 3.2 Instructs and supervises working duties
- 3.3 Holds work meeting with the team
- 3.4 Monitors the logistics process
- 3.5 Manages the logistical aids and warehouse

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Assistant manager logistics wood trade works in the wood trade, where wood and sheet material are imported, stored, processed, and traded.

<p>Access to next level of education/professions A diploma at level 4 gives access to higher professional education. Higher professional education programmes such as for Technical business administration, Industrial product design, Human technology and Architecture are the most logical step. A transfer to an adjoining business sector which handles logistic activities such as warehouses and storage and transshipment is another perspective in terms of broadening the working field.</p>	<p>International agreements The profession of Assistant manager logistics wood trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95757 The education and training for this qualification is offered as of August 1, 2012.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>4 years (6400 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
