3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Pedicurist are:

Core task 1: Carries out preparational tasks, administrative duties and clears up workplace

- 1.1 Receives the client
- 1.2 Preparation of foot investigation and treatment
- 1.3 Carries out foot investigation
- 1.4 Puts together or adjusts treatment plan
- 1.5 Keeps the administration up-to-date and clears up the workspace

Core task 2: Carries out a basic treatment

- 2.1 Carries out basic treatment
- 2.2 Sales and advice about products and services
- 2.3 Finishing and evaluating treatment

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Pedicurists work in the personal care industry in the feet care sector. Pedicurists can work in the following environments: business at home, ambulatory, hospital, medical centre, or care institute. The most usual working environment is the business at home.

<p>Access to next level of education/professions With the certificate of Pedicurist, transfer is possible to a middle management or specialist course (qualification level 4).</p> <p>Horizontal and vertical promotion within the personal care industry to the qualifications of Beautician and Hairdresser is possible. The Pedicurist can become a medical pedicurist. Working as a training instructor is also a possibility. Furthermore, promotion is possible as a business manager, a management position, or self-employed entrepreneur.</p>	<p>International agreements The profession of Pedicurist is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94430 The education and training for this qualification is offered as of August 1, 2009.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
