3. Profile of skills and competences

The most important duties of a Junior navy officer are:

Core task 1: Carries out military basic skills

- 1.1 Prepares a military assignment
- 1.2 Prepares and maintains their equipment and material ready for deployment and maintains them
- 1.3 Makes and keeps him/herself ready for deployment
- 1.4 Maintains himself in the operational environment
- 1.5 Takes measures against CBRN and TIM
- 1.6 Takes measures against munition and mines
- 1.7 Acts in cases of incidents and calamities
- 1.8 Evaluates his performance

Core task 2: Supervises and carries out coordinating tasks

- 2.1 Develops a plan for a team assignment
- 2.2 Communicates the plan to the team
- 2.3 Manages the team
- 2.4 Evaluates the execution of the plan with the team
- 2.5 Carries out talks with individual group members

Core task 3: Gives instruction and training

- 3.1 Works up the team
- 3.2 Solves acknowledged performance problems

Core task 4: Carries out military safety tasks

- 4.1 Carries out surveillance and inspections
- 4.2 Carries out checks on entrances and exits
- 4.3 Carries out radar observations

Core task 5: Carries out nautical and general shipping tasks

- 5.1 Carries out maintenance on maritime unit
- 5.2 Checks and maintains protection means and rescue means
- 5.3 Assists during loading and unloading

The Junior navy officer learns, works and lives in a military environment and carries out tasks as a corporal on board of a maritime unit, both at home and abroad.

Access to next level of education/professions

The Junior navy officer usually transfers after his training to the Royal Navy. A small part of the students continues after the training at the Royal Marechaussee or the Royal Airforce.

With the certificate of Junior navy officer, transfer is possible to a middle management or specialist course (qualification level 4).

International agreements

The profession of Junior navy officer is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95092 The education and training for this qualification is offered as of August 1, 2010.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
