## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Environment officer are:

- maintaining environmental legislation;
- setting up and supervising environmental researches;
- sampling soil and water;
- managing waste supplies;
- drawing up waste plans;
- environmental measuring;
- recommending and reporting on issues of company environment care;
- waste management and environmental research;
- accompanying decontamination.

At these tasks customer contact and contacts with third parties are extremely important. The Environment officer has good social and communicative skills, research skills report skills. He is polite and attentive to the customer. As a result of the continuing changes he is able to see chances and threats his organisation. The Environment officer works independently. The Environment officer is responsible for his own work and in a number of functions also for other people's work. He carries the responsibility for the compliance with the environment laws within the frameworks as put by the competent authority. Moreover he is responsible for its own and other people's security at the implementation of his tasks. As far as it concerns supervisory tasks at public authorities the powers have been regulated in the General Act on Administrative Law chapter 5.

<p><b>Access to next level of education/professions</b> With a diploma at qualification level 4, transfer is possible to higher professional education.</p>	<p><b>International agreements</b> The profession of Environment officer is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
