## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round concrete repairman are:

Core task 1: Repairs concrete

- 1.1 Checks materials and resources
- 1.2 Organises the workplace
- 1.3 Prepares the ground
- 1.4 Repairs concrete manually
- 1.5 Applies pouring concrete
- 1.6 Injects parts of buildings
- 1.7 Applies protection layer
- 1.8 Clears up the workplace

Core task 2: Organises the working duties for colleagues

- 2.1 Divides up working duties and instructs colleagues
- 2.2 Monitors the progress and quality
- 2.3 Attunes and reports about working duties

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round concrete repairman works in one of the approximately 125 concrete repair companies in the sector. These companies are mainly active in civil and utility construction and road construction and hydraulics. The concrete repair sector mainly consists of smaller companies.

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. <p><b>Access to next level of education/professions</b> A diploma All-round concrete repairman means qualification for a position in Supervisor construction implementation and infrastructure level 4 is possible. In general, after additional training and proven competencies the All-round concrete repairman can rise to higher functions in the concrete repair company, such as foreman, operator, planning officer, calculator or business manager. The All-round concrete repairman can also move up to a middle management position such as a level 4 operator, planning officer or calculator.</p>	<p><b>International agreements</b> The profession of All-round concrete repairman is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93942 The education and training for this qualification is offered as of August 1, 2009.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
